# Review of the Huang-Hsiung rotating three-dimensional shallow-water equations

## 1 Introduction

In the literature there are two strategies for deriving the shallow water equations (SWEs) relative to a rotating frame in three dimensions. The first - the strategy of Dillingham, Falzarano \& Pantazopoulos - is reviewed in the report [3]. The second strategy is that of Huang \& Hsiung [10, 8, 9, 11] (hereafter HH). In this report the derivation of HH is reviewed identifying the key assumptions.

The HH derivation is then contrasted with a new third strategy for deriving SWEs using the surface equations derived in [2].

## 2 3D equations relative to a moving frame

The starting point is the momentum equations for the fluid in a vessel relative to a body-fixed coordinate system

\end{equation*}

where $g>0$ is the gravitational constant and

$$
\frac{D u}{D t}:=\frac{\partial u}{\partial t}+u \frac{\partial u}{\partial x}+v \frac{\partial u}{\partial y}+w \frac{\partial u}{\partial z} .
$$

See Appendix A of [1] for a derivation of the momentum equations relative to a moving frame. In equation (2.1) the angular velocity vector $\Omega$ and the translational acceleration vector $\ddot{\mathbf{q}}$ are relative to the body frame.

Conservation of mass takes the usual form

The boundary conditions at the free surface are the kinematic condition

h_{t}+u h_{x}+v h_{y}=w \quad \text { at } \quad z=h(x, y, t), \tag{2.3}
\end{equation*}

and

p=0 \quad \text { at } \quad z=h(x, y, t), \tag{2.4}
\end{equation*}
$$

neglecting surface tension. The boundary condition at the bottom surface and walls is

\mathbf{u} \cdot \mathbf{n}=0 \tag{2.5}
\end{equation*}

Let $\left\{\mathbf{e}_{1}, \mathbf{e}_{2}, \mathbf{e}_{3}\right\}$ be a basis for the body frame $\mathbf{x}$ and $\left\{\mathbf{E}_{1}, \mathbf{E}_{2}, \mathbf{E}_{3}\right\}$ be a basis for the spatial frame $\mathbf{X}$.

## 3 Reduction of conservation of mass

HH start by assuming that $u$ and $v$ are functions of horizontal space coordinates and time and do not depend on the vertical space coordinate

v & :=v(x, y, t) .
\end{align*}
$$

Then integrating the continuity equation from $z=0$ to $z=h(x, y, t)$ leads to

$$
\begin{align*}
& \int_{0}^{h}\left(u_{x}+v_{y}+w_{z}\right) \mathrm{d} z=h\left(u_{x}+v_{y}\right)+\left.w\right|^{h}=h u_{x}+h v_{y}+h_{t}+u h_{x}+v h_{y} \\
& =h_{t}+(h u)_{x}+(h v)_{y}=0 \tag{3.6}
\end{align*}
$$

using the bottom and kinematic free surface boundary conditions. Note that $u$ and $v$ in equation (3.6) can be interpreted as the depth-averaged horizontal velocities,

(h \bar{v})_{y}= & \frac{\partial}{\partial y} \int_{0}^{h} v(x, y, z, t) \mathrm{d} z=\left.h_{y} v(x, y, z, t)\right|^{h}+\int_{0}^{h} v_{y} \mathrm{~d} z \\
\Rightarrow \quad \int_{0}^{h}\left(u_{x}+v_{y}+w_{z}\right) \mathrm{d} z= & (h \bar{u})_{x}+(h \bar{v})_{y}-\left.h_{x} u(x, y, z, t)\right|^{h}-\left.h_{y} v(x, y, z, t)\right|^{h} \\
& +\left.w(x, y, z, t)\right|^{h}=h_{t}+(h \bar{u})_{x}+(h \bar{v})_{y}=0,
\end{aligned}
$$

applying the bottom and kinematic free surface boundary conditions.

## 4 Vertical momentum and the pressure field

The vertical momentum equation can be expressed in the form

\frac{D w}{D t}+\frac{1}{\rho} \frac{\partial p}{\partial z}=-2\left(\Omega_{1} v-\Omega_{2} u\right)+\left(\Omega_{1}^{2}+\Omega_{2}^{2}\right)\left(z+d_{3}\right)+\beta(x, y, t), \tag{4.8}
\end{equation*}
$$

where

$$
\beta(x, y, t)=-\left(\dot{\Omega}_{1}+\Omega_{2} \Omega_{3}\right)\left(y+d_{2}\right)+\left(\dot{\Omega}_{2}-\Omega_{1} \Omega_{3}\right)\left(x+d_{1}\right)-\ddot{\mathrm{q}}_{3}-g \mathbf{e}_{3} \cdot \mathbf{Q}^{T} \mathbf{E}_{3} .
$$

The second assumption of HH is to neglect the vertical acceleration

$$

\frac{D w}{D t} \approx 0 . \tag{HH-2}
\end{equation*}
$$

The vertical momentum equation then reduces to

\frac{1}{\rho} \frac{\partial p}{\partial z}=-2\left(\Omega_{1} v-\Omega_{2} u\right)+\left(\Omega_{1}^{2}+\Omega_{2}^{2}\right)\left(z+d_{3}\right)+\beta(x, y, t),
$$

Integration of this equation from any point $z$ to the surface $h$ gives an expression for the pressure field at any point $z$

\frac{1}{\rho} p(x, y, z, t)= & (h-z)\left(2 \Omega_{1} v-2 \Omega_{2} u-\beta(x, y, t)\right) \\
& +\frac{1}{2}\left(\Omega_{1}^{2}+\Omega_{2}^{2}\right)\left(\left(z+d_{3}\right)^{2}-\left(h+d_{3}\right)^{2}\right), \tag{4.9}
\end{align*}
$$

where the dynamic free surface boundary condition has been used on the left hand side. In the reduction of the horizontal momentum equations, the horizontal pressure gradient is needed. Differentiating (4.9),

& +\left(2 \Omega_{1} v_{x}-2 \Omega_{2} u_{x}-\dot{\Omega}_{2}+\Omega_{1} \Omega_{3}\right)(h-z)
\end{align*}
$$

and

$$
\begin{align*}
\frac{1}{\rho} \frac{\partial p}{\partial y}= & \left(2 \Omega_{1} v-2 \Omega_{2} u-\left(\Omega_{1}^{2}+\Omega_{2}^{2}\right)\left(h+d_{3}\right)-\beta(x, y, t)\right) h_{y}  \tag{4.11}\\
& +\left(2 \Omega_{1} v_{y}-2 \Omega_{2} u_{y}+\dot{\Omega}_{1}+\Omega_{2} \Omega_{3}\right)(h-z)
\end{align*}
$$

## 5 Reduction of the horizontal momentum

The $x$-component of the momentum equations (2.1) is

\begin{align*}
\frac{D u}{D t}+\frac{1}{\rho} \frac{\partial p}{\partial x}= & -2\left(\Omega_{2} w-\Omega_{3} v\right)-\dot{\Omega}_{2}\left(z+d_{3}\right)+\dot{\Omega}_{3}\left(y+d_{2}\right)  \tag{5.12}\\
& -\Omega_{1} \boldsymbol{\Omega} \cdot(\mathbf{x}+\mathbf{d})+\left(x+d_{1}\right)\|\boldsymbol{\Omega}\|^{2}-\ddot{\mathrm{q}}_{1}-g \mathbf{e}_{1} \cdot \mathbf{Q}^{T} \mathbf{E}_{3} .
\end{align*}
$$

Since $u_{z}=0, \frac{D u}{D t}$ reduces to

Now substitution of $\frac{D u}{D t}$ and $\frac{1}{\rho} \frac{\partial p}{\partial x}$ from (4.10) into the $x-$ momentum equation gives

& +\left(2 \Omega_{1} v_{x}-2 \Omega_{2} u_{x}-\dot{\Omega}_{2}+\Omega_{1} \Omega_{3}\right)(h-z)+2\left(\Omega_{2} w-\Omega_{3} v\right)+\dot{\Omega}_{2}\left(z+d_{3}\right) \\
& -\dot{\Omega}_{3}\left(y+d_{2}\right)+\Omega_{1} \boldsymbol{\Omega} \cdot(\mathbf{x}+\mathbf{d})-\left(x+d_{1}\right)\|\boldsymbol{\Omega}\|^{2}+\ddot{\mathrm{q}}_{1}+g \mathbf{e}_{1} \cdot \mathbf{Q}^{T} \mathbf{E}_{3}=0 \tag{5.13}
\end{align*}
$$

The third assumption of HH is

Then integrating equation (5.13) from $z=0$ to $z=h(x, y, t)$ gives

& u_{t}+u u_{x}+v u_{y}+\left(2 \Omega_{1} v-2 \Omega_{2} u-\left(\Omega_{1}^{2}+\Omega_{2}^{2}\right)\left(h+d_{3}\right)-\beta(x, y, t)\right) h_{x} \\
& +\left(\Omega_{1} v_{x}-\Omega_{2} u_{x}+\Omega_{1} \Omega_{3}\right) h-2 \Omega_{3} v+\left(\Omega_{1} \Omega_{2}-\dot{\Omega}_{3}\right)\left(y+d_{2}\right)  \tag{5.14}\\
& -\left(\Omega_{2}^{2}+\Omega_{3}^{2}\right)\left(x+d_{1}\right)+\left(\dot{\Omega}_{2}+\Omega_{1} \Omega_{3}\right) d_{3}+\ddot{\mathrm{q}}_{1}+g \mathbf{e}_{1} \cdot \mathbf{Q}^{T} \mathbf{E}_{3}=0 .
\end{align*}
$$

The fourth assumption of HH is

Note that $\Omega_{1} v_{x}-\Omega_{2} u_{x}$ is half of the $x$-derivative of vertical component of the Coriolis force. Finally equation (5.14) simplies to

& +\left(h+d_{3}\right) \Omega_{1} \Omega_{3}-2 \Omega_{3} v+\left(\Omega_{1} \Omega_{2}-\dot{\Omega}_{3}\right)\left(y+d_{2}\right)  \tag{5.15}\\
& -\left(\Omega_{2}^{2}+\Omega_{3}^{2}\right)\left(x+d_{1}\right)+\dot{\Omega}_{2} d_{3}+\ddot{\mathrm{q}}_{1}+g \mathbf{e}_{1} \cdot \mathbf{Q}^{T} \mathbf{E}_{3}=0 .
\end{align*}

This is the form of the $x$-momentum component of the SWEs that appears in [10, 11].

### 5.1 Reduction of the $y$-momentum equation

The $y$-component of the momentum equations (2.1) is

& -\Omega_{2} \boldsymbol{\Omega} \cdot(\mathbf{x}+\mathbf{d})+\left(y+d_{2}\right)\|\boldsymbol{\Omega}\|^{2}-\ddot{\mathrm{q}}_{2}-g \mathbf{e}_{2} \cdot \mathbf{Q}^{T} \mathbf{E}_{3} . \tag{5.16}
\end{align*}
$$

Since $v_{z}=0, \frac{D v}{D t}$ reduces to

$$

Now substitution of $\frac{D v}{D t}$ and $\frac{1}{\rho} \frac{\partial p}{\partial y}$ from (4.11) into the $y$-momentum equation gives

& +\left(2 \Omega_{1} v_{y}-2 \Omega_{2} u_{y}+\dot{\Omega}_{1}+\Omega_{2} \Omega_{3}\right)(h-z)-2\left(\Omega_{1} w-\Omega_{3} u\right)-\dot{\Omega}_{1}\left(z+d_{3}\right) \\
& +\dot{\Omega}_{3}\left(x+d_{1}\right)+\Omega_{2} \boldsymbol{\Omega} \cdot(\mathbf{x}+\mathbf{d})-\left(y+d_{2}\right)\|\boldsymbol{\Omega}\|^{2}+\ddot{\mathrm{q}}_{2}+g \mathbf{e}_{2} \cdot \mathbf{Q}^{T} \mathbf{E}_{3}=0 . \tag{5.17}
\end{align*}

The fifth assumption is

Then integrating equation (5.17) from $z=0$ to $z=h(x, y, t)$ gives

& +\left(\Omega_{1} v_{y}-\Omega_{2} u_{y}+\Omega_{2} \Omega_{3}\right) h+2 \Omega_{3} u+\left(\Omega_{1} \Omega_{2}+\dot{\Omega}_{3}\right)\left(x+d_{1}\right)  \tag{5.18}\\
& -\left(\Omega_{1}^{2}+\Omega_{3}^{2}\right)\left(y+d_{2}\right)+\left(-\dot{\Omega}_{1}+\Omega_{2} \Omega_{3}\right) d_{3}+\ddot{\mathrm{q}}_{2}+g \mathbf{e}_{2} \cdot \mathbf{Q}^{T} \mathbf{E}_{3}=0
\end{align*}
$$

The sixth assumption is

note that $\Omega_{1} v_{y}-\Omega_{2} u_{y}$ is half of the $y$-derivative of vertical component of the Coriolis force. Finally equation (5.18) simplies to

& +\left(h+d_{3}\right) \Omega_{2} \Omega_{3}+2 \Omega_{3} u+\left(\Omega_{1} \Omega_{2}+\dot{\Omega}_{3}\right)\left(x+d_{1}\right)  \tag{5.19}\\
& -\left(\Omega_{1}^{2}+\Omega_{3}^{2}\right)\left(y+d_{2}\right)-\dot{\Omega}_{1} d_{3}+\ddot{\mathrm{q}}_{2}+g \mathbf{e}_{2} \cdot \mathbf{Q}^{T} \mathbf{E}_{3}=0 .
\end{align*}

This is the form of the $y$-momentum component of the SWEs that appears in [10, 11].

The assumptions (HH-4) and (HH-6) can be written in a concise vector form

h \nabla\left[(\boldsymbol{\Omega} \times \mathbf{u}) \cdot \mathbf{e}_{3}\right] \approx 0 .

## 6 Prescribed yaw-pitch-roll motion of the vessel

The rotation matrix in $[9,10,11]$ is restricted to

$$
\mathbf{Q}=\left[\begin{array}{ccc}
\cos \psi \cos \theta & -\sin \psi \cos \phi+\cos \psi \sin \theta \sin \phi & \boxed{\sin \psi \sin \phi+\cos \psi \sin \theta \cos \phi}  \tag{HH-7}\\
\sin \psi \cos \theta & \cos \psi \cos \phi+\sin \psi \sin \theta \sin \phi & -\cos \psi \sin \phi+\sin \psi \sin \theta \cos \phi \\
-\sin \theta & \cos \theta \sin \phi & \cos \theta \cos \phi
\end{array}\right] .
$$

This matrix is equation (7) in [11] with two typos corrected. The first boxed term is incorrectly typed as $\sin \theta$ in [11] and the second boxed term is incorrectly typed
as $\sin \phi$ in [11]. The correspondence with the notation in [11] is $\phi=e_{1}, \theta=e_{2}$ and $\psi=e_{3}$.

The connection between the rotation matrix (HH-7) and a yaw-pitch-roll sequence is best demonstrated using rotation tensors, and the details of this construction are given in the report [6].

The angular velocity can be deduced using the matrix representation or by using the properties of rotation tensors. The spatial angular velocity is

\boldsymbol{\Omega}^{s}=\dot{\psi} \mathbf{E}_{3}+\dot{\theta} \mathbf{a}_{2}+\dot{\phi} \mathbf{b}_{1}
$$

The 3-2-1 Euler angles have a singularity at $\theta= \pm \frac{1}{2} \pi$ and so $\theta$ must be restricted to the interval

$$
-\frac{\pi}{2}<\theta<\frac{\pi}{2}
$$

The singularity arises because the map from $(\dot{\psi}, \dot{\theta}, \dot{\phi})$ to $\Omega^{s}$ is not invertible when $\cos \theta=0$. To see this write out the map

0 & -\sin \psi & \cos \psi \cos \theta \\
0 & \cos \psi & \sin \psi \cos \theta \\
1 & 0 & -\sin \theta
\end{array}\right]\left(\begin{array}{c}
\dot{\psi} \\
\dot{\theta} \\
\dot{\phi}
\end{array}\right)
$$

The determinant of the coefficient matrix is $-\cos \theta$ resulting in a singularity when $\cos \theta=0$.

The body angular velocity is

$$
\begin{aligned}
\mathbf{\Omega}^{b}= & \dot{\psi}\left(-\mathbf{E}_{1} \sin \theta+\mathbf{E}_{2} \cos \theta \sin \phi+\mathbf{E}_{3} \cos \theta \cos \phi\right) \\
& +\dot{\theta}\left(\mathbf{E}_{2} \cos \phi-\mathbf{E}_{3} \sin \phi\right)+\dot{\phi} \mathbf{E}_{1} \\
= & \mathbf{E}_{1}(\dot{\phi}-\dot{\psi} \sin \theta)+\mathbf{E}_{2}(\dot{\psi} \cos \theta \sin \phi+\dot{\theta} \cos \phi) \\
& +\mathbf{E}_{3}(\dot{\psi} \cos \theta \cos \phi-\dot{\theta} \sin \phi)
\end{aligned}
$$

In [14] the body angular velocity is denoted by $\boldsymbol{\omega}_{0 \mathbf{R}}$ and the above expression for $\boldsymbol{\Omega}^{b}$ agrees with $\boldsymbol{\omega}_{0 \mathbf{R}}$ on page 188 of [14]. In matrix form

\end{array}\right)=\left[\begin{array}{ccc}
1 & 0 & -\sin \theta \\
0 & \cos \phi & \cos \theta \sin \phi \\
0 & -\sin \phi & \cos \theta \cos \phi
\end{array}\right]\left(\begin{array}{c}
\dot{\phi} \\
\dot{\theta} \\
\dot{\psi}
\end{array}\right)
$$

This mapping is also singular when $\cos \theta=0$. Write this mapping in matrix-vector form

$$
\Omega^{b}=\mathbf{B}^{-1} \dot{\Theta}
$$

Then

$$
\mathbf{B}=\left[\begin{array}{ccc}
1 & \sin \phi \tan \theta & \cos \phi \tan \theta \\
0 & \cos \phi & -\sin \phi \\
0 & \sin \phi \sec \theta & \cos \phi \sec \theta
\end{array}\right]
$$

As shown below in $\S 6.1$, this expression agrees with $[B]:=\mathbf{B}$ in [7] and in [11].
Further details on the $3-2-1$ Euler angles are in the report [6].

### 6.1 Notation in [11]

On page 222 of [11] the ship translational displacements, denoted by $\left(\xi_{1}, \xi_{2}, \xi_{3}\right)$, in the steady moving system and the Eulerian angles, denoted by $\left(e_{1}, e_{2}, e_{3}\right)$, are related by

This is equation (5) in [11]. In equations (6)-(7) in [11], the matrices $[B]$ and $[R]$ are defined as follows

0 & \cos e_{1} & -\sin e_{1} \\
0 & \sin e_{1} \sec e_{2} & \cos e_{1} \sec e_{2}

and

Replacing $e_{1}=\phi, e_{2}=\theta, e_{3}=\psi$ and $\xi_{1}=q_{1}, \xi_{2}=q_{2}$ and $\xi_{3}=q_{3}$ it is clear (after correcting two boxed typos in $[R])$ that $[R]=\mathbf{Q}$ and $[B]=\mathbf{B}$. The first boxed term should be $\sin e_{2} \rightarrow \sin e_{3}$ and the second boxed term should be $\sin e_{1} \rightarrow \cos e_{1}$. In (6.20), the angular velocity $\left(u_{4}, u_{5}, u_{6}\right)$ is related to the Euler angles by

## 10 Numerical simulations

Numerical simulations are performed using the new surface SWEs in [2]. The numerical scheme is detailed in $[2,5]$. In the simulations the initial conditions are

U(x, y, 0)=V(x, y, 0)=0 \quad \text { and } \quad h(x, y, 0)=h_{0},
$$

with $h_{0}$ input. Other required inputs are

L_{1}, \quad L_{2}, \quad d_{1}, \quad d_{2}, \quad d_{3},

and the functions associated with the rigid body motion of the vessel

\Omega_{1}, & \Omega_{2}, & \Omega_{3}, \quad q_{1}, \quad q_{2}, \quad q_{3} .

### 10.1 Numerical results for surge-sway forcing

This example is motivated by the numerics in [10]. They set the following parameter values

$$
L_{1}=1, \quad L_{2}=0.8, \quad h_{0}=0.10, \quad d_{1}=-0.50, \quad d_{2}=-0.40, \quad d_{3}=0.0,
$$

with all units in metres. There is no rotation so $\Omega_{1}=\Omega_{2}=\Omega_{3}=0$. The translational motion is surge and sway and they take the form

$$
q_{1}(t)=q_{2}(t)=\varepsilon_{5} \sin \left(\omega_{4} t\right), \quad q_{3}(t)=0,
$$

with

$$
\varepsilon_{4}=0.02, \quad \varepsilon_{5}=0.02, \quad \text { and } \quad \omega_{4}=6.0,
$$

with the amplitude in metres and the units of $\omega_{4}$ are radians per second.
A example simulation using the code in $[2,5]$ is shown in Figure 1. The wave surface due to the coupled surge and sway motions is shown at $t=1.50 \mathrm{sec}$. The corresponding velocity distribution is shown in Figure 2. Further discussion of these results is in [2].

### 10.2 Numerical results for yaw forcing

In this section numerical results for pure yaw motion are shown. The parameter values are the same as the surge-sway example with a different forcing. The forcing is pure yaw motion so that $q_{1}=q_{2}=q_{3}=0$ and

$$
\mathbf{Q}=\left[\begin{array}{ccc}
\cos \psi & -\sin \psi & 0 \\
\sin \psi & \cos \psi & 0 \\
0 & 0 & 1
\end{array}\right]
$$

Hence the angular velocity is

$$
\Omega_{1}=0, \quad \Omega_{2}=0, \quad \Omega_{3}=\dot{\psi} .
$$

The yaw angle is prescribed to be harmonic

$$
\psi(t)=\varepsilon_{3} \sin \left(\omega_{3} t\right),
$$

with

$$
\varepsilon_{3}=4.0^{\circ}=\frac{\pi}{45} \mathrm{rad}, \quad \text { and } \quad \omega_{3}=6.0 \mathrm{rad} / \mathrm{sec} .
$$

The wave surface under only the yaw motion at $t=1.50 \mathrm{sec}$ is depicted in figure 3. The corresponding velocity distribution is shown in figure 4. Further discussion of these results is in [2].


Figure 4: Velocity field due to yaw: comparison of the numerics based on the surface SWEs with Figure 29 of [10]. The data are $t=1.5 \mathrm{sec}, \omega=6.0 \mathrm{rad} / \mathrm{sec}, L_{1}=1 \mathrm{~m}$ and $L_{2}=0.8 \mathrm{~m}$.

### 10.3 Some properties of the SWEs for pure yaw forcing

In the case of pure yaw forcing, the coefficients in the surface SWEs reduce considerably. With $\Omega_{1}=\Omega_{2}=0$ and $\Omega_{3}=\dot{\psi}$,

\begin{aligned}

a_{12} & =a_{21}=0 \\
b_{1} & =2 \Omega_{3} V+\Omega_{3}^{2}\left(x+d_{1}\right)+\dot{\Omega}_{3}\left(y+d_{2}\right) \\
b_{2} & =-2 \Omega_{3} U+\Omega_{3}^{2}\left(y+d_{2}\right)-\dot{\Omega}_{3}\left(x+d_{1}\right) .
\end{aligned}
$$

In this case the surface equations and the HH equations are identical and the momentum equations reduce to forced classical SWEs

$$
\begin{align*}
U_{t}+U U_{x}+V U_{y}+g h_{x} & =2 \dot{\psi} V+\dot{\psi}^{2}\left(x+d_{1}\right)+\ddot{\psi}\left(y+d_{2}\right)  \tag{10.9}\\
V_{t}+U V_{x}+V V_{y}+g h_{y} & =-2 \dot{\psi} U+\dot{\psi}^{2}\left(y+d_{2}\right)-\ddot{\psi}\left(x+d_{1}\right) .
\end{align*}
$$

These equations have the remarkable property that they conserve a form of potential vorticity. Let

\mathscr{P}:=\frac{V_{x}-U_{y}+2 \dot{\psi}}{h} .
$$

It is proved in [2] that $\mathscr{P}$ is a Lagrangian invariant

$$
\frac{D \mathscr{P}}{D t}=0 .
$$
